

JAIST Guidelines to Prevent the Spread of COVID-19 as of April 1, 2023

※Criterion of the levels are as follows.

Level 1 the risk of infection is significantly decreased

Level 2 the risk of infection is decreased

Level 3 there is a risk of infection spread in Ishikawa prefecture, but state of emergency is not declared for Ishikawa prefecture or neighboring areas

Level 4 the infection has spread, community medical care is tight, and a state of emergency is declared for Ishikawa prefecture or neighboring areas

Level 5 the infection has spread, community medical care is tight, and state of emergency is declared nationwide

Level 6 in addition to the Level 5 situation, there are requests from the national or prefectural governments to close the campus
